#### **APPLICATION PROCESS**

## **Submit your application form and CV**

Send your fully completed application form, curriculum vitae, a brief letter of motivation and a copy of your ID card or valid passport by 22 July 2021 to: formazione@icraproject.it

# Outcome of your application

You will be notified on the outcome of your application by 26 July2021. If successful, you will receive the admission form with the terms and procedure of enrolment and the COVID-19 self-certification form.

### Waiting list

If unsuccessful due to the limited number of places available, you will be placed on a waiting list. You will be notified by 30 July 2021 if a place becomes available.

### **Enrolment**

Pay the full Masterclass enrollment fee and send the following documents by 3 August 2021:

- 1. copy of your bank transfer remittance;
- 2. copy of your Italian tax code (codice fiscale);
- 3. certificate of a negative COVID-19 test;
- 4. completed COVD-19 self-certification form;
- 5. **if you are a non-EU citizen residing abroad**, a copy of your visa **valid for the duration of the Masterclass.** For information on visas please visit the <u>dedicated website</u>

#### SECTION 1 - NUMBER OF AVAILABLE PLACES

There are **16** places available for the Masterclass – International Performing Arts Summer 2021.

#### **SECTION 2 – ENTRY REQUIREMENTS**

In order to attend the Masterclass – International Performing Arts Summer 2021, a secondary school leaving certificate (e.g. high school diploma) is required.

The following knowledge and skills are also required:

- good general knowledge;
- good command of Italian;
- good motor skills and coordination.

The above knowledge and skills will be assessed based on the letter of motivation.

#### **SECTION 3 – HOW TO APPLY**

Send the **fully completed application form**, your **curriculum vitae**, **a brief letter of motivation** and a copy of your **ID card or valid passport** to **formazione@icraproject.it** by **22 July 2021**. The application form is available on the web page of the Masterclass.

You will be notified of the outcome of your application by 26 July 2021.

There are no tests or examinations.

#### REMEMBER

- It is essential that you complete the application form as fully and accurately as possible (name, surname, date and place of birth, and Italian tax code). Check your e-mails regularly, especially after the application deadline.

#### **SECTION 4 – OUTCOME OF YOUR APPLICATION**

You will be notified on the outcome of your application as follows:

OFFERED A PLACE: You will receive an offer letter. You must enrol by 3 August 2021 or you will lose your confirmed place and will be placed on a waiting list.

**ELIGIBLE**: you are not admitted to the course due to the limited number of places available, but you will be placed on a waiting list. You will be notified by 30 July 2021 if a place becomes available.

UNSUCCESSFUL: You did not meet all the requirements, but you can apply again next year for the Masterclass – International Performing Arts Summer 2022.

#### **SECTION 5 - ENROLMENT**

The enrolment fee for the Masterclass – International Performing Arts Summer is €150.00.

If you are **OFFERED A PLACE**, you must pay in full the enrolment fee of €150.00 by 3 August 2021. This payment deadline must be strictly adhered to.
