APPLICATION PROCESS



Send your fully completed application form by 4 September 2023 to: formazione@icraproject.it

If successful, you will receive the offer letter with the terms and procedure of enrolment, the academic regulations, the coronavirus safety protocol, and the COVID-19 self-certification form.

Candidates who meet the entry requirements are admitted to the course in the order in which applications are received and subject to the number of places available.

If unsuccessful due to the limited number of places available, you will be placed on a waiting list. You will be notified by 12 September if a place becomes available.

On 29 September, three days before classes begin, please send the following documents:

- 1. certificate of a negative COVID-19 test;

- 6. a medical certificate that confirms you are fit and healthy and do not suffer from a heart condition;

SECTION 1 – NUMBER OF AVAILABLE PLACES

There are **12** places available for the 2023 academic year.

SECTION 2 – ENTRY REQUIREMENTS

In order to attend the **Second Cycle Professional Development – Expressive Skills & Dramatic Arts Lab**, in addition to ICRA Project's 1st Cycle Programme certificate obtained in the past **10 years**, a secondary school leaving certificate (e.g. high school graduation diploma) is required.

These certificates will be declared on the application form.

SECTION 3 – HOW TO APPLY

You must fully complete the **application form** available from the web page of the Second Cycle Professional Development programme and send it to **formazione@icraproject.it** by **4 September 2023.**

You will be notified on the outcome of your application within one week of the closing date.

There are no tests or examinations.

REMEMBER

- It is essential that you complete the application form as fully and accurately as possible (name, surname, date and place of birth, and Italian tax code). **Check your e-mails regularly, especially after the deadline**.

SECTION 4 – OUTCOME OF YOUR APPLICATION

You will be notified on the outcome of your application as follows:

OFFERED A PLACE: You will receive an offer letter, the academic regulations, a copy of the coronavirus safety protocol and the COVID-19 self-certification form. You must enrol by 18 September 2023 or you will lose your confirmed place and will be placed on a waiting list.

ELIGIBLE: you are not admitted to the course due to the limited number of places available, but you will be placed on a waiting list. You will be notified by 12 September 2023 if a place becomes available.

SECTION 5 – ENROLLEMENT

The tuition fee for the Second Cycle Professional Development – Expressive Skills & Dramatic Arts Lab programme is €1,000.00 to be paid in two instalments as follows:

If you are OFFERED A PLACE, the first instalment of €700.00 must be paid in full by 18 September 2023 and the second instalment of €300.00 by 11 October 2023. All payment deadlines must be strictly adhered to.
